March 3, 2024	REGULAR GENERAL COUNCIL MEETING – 10am. Approve the list of qualified voters (60 days prior to Tribal Election). Note: If any additions/deletions are made to this list at this time, the list will be presented back to the general council for final approval at a Special General Council meeting
March 3, 2024	REGULAR GENERAL COUNCIL MEETING – Candidates for election shall be nominated. Candidates shall follow-up in writing to the election board chairperson announcing their intentions. Eligible voters who may also want to run must announce their intentions in writing at this time to be given to Tribal Chairperson who in return hands to Election Chairperson. March 3, 2024 last day for nominated candidates to file "letter of intent" .
March 17, 2024	Deadline for written appeals for omitted names from eligible voters list.
March 18, 2024	SPECIAL GENERAL COUNCIL MEETING – 7:30 p.m. – (15 days from March 3, 2024). <u>If necessary – approve amended changes to the qualified voters list.</u>
March 25, 2024	Absentee Voting Ballots Made Available – (40 days prior to Tribal Election). Will be sent "Upon Request" to qualified voters.
April 4, 2024	Post list of "Eligible Voter's List" and Election notices advertised and posted. (30 days prior to Tribal Election)
April 24, 2024	Deadline to Request Absentee Voting Ballot. (10 days prior to Election)
May 3, 2024	Deadline at 4:30 p.m. For Absentee Voting Ballots. Absentee voting ballots must be received "certified return receipt."
May 4, 2024 (Saturday)	ELECTION DAY 7 A.M to 7 P.M. The General Council will assemble in an open meeting the night of the election at 7:00 p.m. after the closing of the polls.
